CITY OF RED DEER LOAN BYLAW

Central Alberta Humane Society Loan Bylaw Amendment

Red Deer City Council proposes to pass the following bylaw to provide for a loan deferral for the year 2024 on a \$923,155.07 loan from 2007 held by the Central Alberta Humane Society. The loan was for the purpose of assisting with the construction of their new facilities. The current balance owing is \$500,681.74. Interest still accrues at 3.6% annually, even with the payment deferral. The public may inspect the proposed bylaw at Legislative Services, City Hall, during regular office hours.

CANADIAN NAVIGABLE WATERS ACT

The City of Red Deer hereby gives notice that an application has been made to the Minister of Transport, pursuant to the Canadian Navigable Waters Act for approval of the work described herein and its site and plans.

Pursuant to paragraph 7(2) of the said Act, **the City of Red Deer** has deposited with the Minister of Transport, on the on-line Common Project Search Registry (http://cps.canada.ca/) and under registry number 9867, or, under the NPP File Number 2024-611698, a description of the following work, its site and plans:

CPR Pedestrian Bridge Rehabilitation, which includes the following project scope:

- Installation and removal of temporary in-water berms, working platforms, fish passage boulders, and isolation covering approximately 60% of river cross-section
- Replacement of concrete substructure (piers and abutment) in new downstream location and removal of existing substructure
- · Relocation, re-painting, and repair of steel trusses
- Replacement of timber trestle
- Installation of new concrete deck and steel handrails on steel trusses and timber trestle
- Installation of temporary and permanent heavy rock rip rap on left and right banks
- Bank grading and re-vegetation

in, on, over, under, through or across the Red Deer River in Red Deer, Alberta from 5804 53 Avenue to 5530 50 (Gaetz) Avenue.
